Understanding Co-Pastor Appointment

The Foursquare Church reaffirms the support of all pastors. This document is to provide guidance and context for the Co-Pastor role.

Is a Co-Pastor appointment the right fit?

CO-PASTOR

Co-Pastors agree with and adhere to the qualifications, selection, guidelines, and duties as listed in 14.1 to describe “The Senior Pastor*” within the Handbook of Operations for the Foursquare Church.

RESPONSIBILITY

Co-Pastors **share an equal distribution of responsibility** and congregational leadership authority.

DECISION MAKING

Co-Pastors **share decision-making processes and legal responsibilities** with the senior pastor such as check signing authority and sponsorship of applicants for ministry credentials.

CHURCH COUNCIL

Co-Pastors **share oversight of congregational decisions**. Co-Pastors collaborate with church councils. One Co-Pastor* serves as the chairperson of the council.

SALARY & BENEFITS

Co-Pastors are **entitled to commensurate salary and benefits** traditionally ascribed to a senior pastor.

ASSISTANT PASTOR

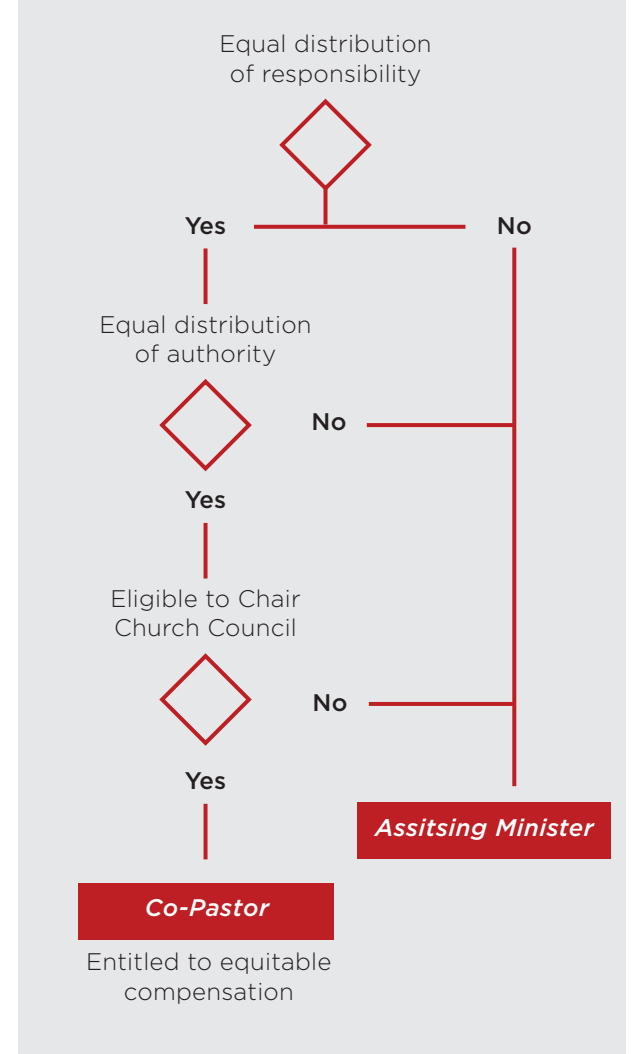
Assisting ministers generally serve as an assistant pastor overseeing youth, children, visitation, administration or worship ministries or hold another ministry title assigned by the senior pastor.

Assisting ministers are sought and selected by the Co-Pastors*. Assisting ministers report to and serve under the authority of the Co-Pastors*.

All major plans, programs, and policies under the guidance of an assistant pastor should be discussed with the Co-Pastors and should not be implemented without their approval.

Assisting ministers meet with the council and serve the congregation under the Co-Pastor’s* leadership.

Assisting ministers often receive smaller salaries than Co-Pastors, and sometimes they serve without compensation.
